Cash deposit or transfer from any other account will not be considered, if arise, the tender will not be accepted. BANK DRAFT/ PAY ORDER will not be accepted.

The tenderer will have to submit their bid **on-line** in two cover/folder system containing pre qualification document (**Technical Bid**) in one and **Financial Bid** in another. 


